Automated Commercial Environment (ACE)

WHAT IT IS:

ACE is the CBP's Online system for processing trade-related data and transactions. It serves as the primary platform for submitting import and export documentation, managing customs clearance, and ensuring compliance with U.S. trade laws.

WHY IT'S IMPORTANT:

- **Centralized Trade Management:** ACE streamlines the submission of import/export data, reducing paperwork and manual errors.
- Faster Clearance: Automated processing speeds up customs clearance, minimizing delays and demur-rage fees.
- **Transparency & Compliance:** Importers, customs brokers, and other stakeholders can track shipment status, duty payments, and compliance requirements in real time.
- Integration with Partner Government Agencies (PGAs): ACE connects with agencies like the FDA, USDA, and EPA, ensuring that all regulatory approvals are processed through one system.

Automated Clearinghouse (ACH)

WHAT IT IS:

ACH is an electronic payment system that allows importers and brokers to pay CBP duties, taxes, and fees directly from their bank accounts. It eliminates the need for checks or manual payments.

- Faster & More Secure Payments: ACH enables seamless transactions without physical paperwork.
- Avoids Payment Delays: Since funds are transferred electronically, payments are processed quickly, reducing the risk of late fees.

- CBP Approved Recognized and encouraged by U.S. Customs for streamlined compliance

CBP debits the importer's account for duties 10 business days after cargo release.

Periodic Monthly Statement (PMS)

WHAT IT IS:

PMS is a CBP program that allows importers and brokers to consolidate multiple duty payments into a single monthly payment, instead of paying on a per-entry basis.

WHY IT'S IMPORTANT:

- Flexible Payment Terms: PMS extends the duty payment deadline to the 15th working day of the following month, giving businesses more time to manage cash flow.
- Simplifies Accounting: Instead of tracking individual payments for every shipment, importers can consolidate everything into one monthly statement.
- Enhances Financial Control: By batching payments, companies can plan their finances better and avoid unnecessary transaction fees.
