Dear Valued Customer,

On April 9, 2025, the President of the United States signed a sweeping Executive Order enacting a 125% tariff on all Chinese imports, effective 12:01 a.m. ET on April 10. This action amends the Harmonized Tariff Schedule of the United States (HTSUS) under the authority of the International Emergency Economic Powers Act (IEEPA) and Executive Order 14257, originally issued April 2.

Simultaneously, the Order establishes a 90-day reciprocal tariff pause for over 75 trading partners that have taken steps toward resolving trade imbalances. These countries will now operate under a temporary 10% ad valorem duty rate through July 9, 2025, unless otherwise extended.

 125% Tariff Applies to China (PRC, incl. Hong Kong and Macau)
All imports from China not in transit prior to April 10 will be subject

to the new duty rate.

• **90-Day Pause Applies to "Annex I" Countries** These partners will see a reduction from retaliatory duties to a uniform 10% rate. The pause ends July 9.
